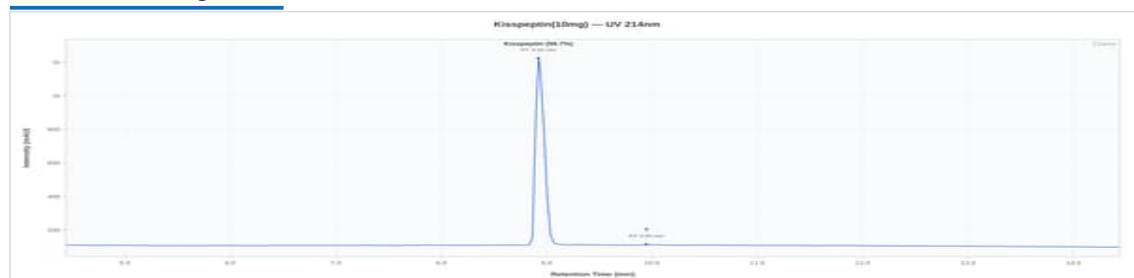

Notes & Methodology

- Date Tested: 06/28/2026. Methods: Purity & Quant (HPLC).
- The sample was confirmed to be KissPeptin-10 by HPLC. Identification by chromatographic retention time comparison with a reference standard.
- Peptide purity determined by RP-HPLC area normalization at 214 nm. Value represents the percentage of the target peptide relative to all peptide-related peaks. Non-peptide process-related impurities, if detected, are excluded from the calculation.
- Chromatogram shown is representative: Dedicated V0 (99.74% purity, closest to batch mean of 99.77%).
